NOTICE INVITING LIMITED TENDER (NILT)

Sealed Limited Tenders are hereby invited by the undersigned on behalf of the President of India for "**HIRING OF MID-SIZE A/C DLY TAXIS LIKE INDIGO/ESTEEM/ACCENT AND NON-A/C 8 SEATER COMMERCIAL VEHICLES ON NEED BASIS from the date of signing the agreement for 06 months** as per terms & conditions mentioned below and details enclosed. Interested bonafide reputed approved Taxi operators / Agencies may send their Tender in the prescribed Performa in sealed envelope on or before **17:00 hrs on 30th May 2012** to the Assistant Director (CCTNS-I), NCRB, East Block-7, R.K. Puram, New Delhi – 110066. Tender No., name of the work and date of opening of the tender must be clearly mentioned on the envelope.

Details of Works and Specifications: As per details enclosed.

Terms & Conditions :

1. Tender must be on the letter head of the firm in the enclosed prescribed Performa.
2. Rates shall be quoted inclusive of all taxes except service tax which shall be as per actual in the prescribed schedule of quantities (Enclosed). The rates must be quoted in figures as well as in words.
3. Taxes and other charges, if any must be indicated separately.
4. **No overwriting or cutting is permitted in the rates quoted. The same shall render the tender invalid. However, except rates** every cutting and over writings must be signed by the authorized person of the firm.
5. The rates quoted must be valid for a minimum of 90 days from the date of opening of the tender and silence on this issue shall be treated as agreement to this condition.
6. **The firm / agency may satisfy the following conditions:**
 - a. Firm shall be registered with Govt. of Delhi for providing Taxi services.
 - b. The firm shall have valid Service Tax Number, Income Tax Return and PAN.
 - c. The firm shall have minimum of 5 Nos. of Taxis and 5 Nos. of trained drivers having valid license.
 - d. Firm shall supply latest model car in good condition and well mannered & experienced drivers.

7. Terms of Payment:

- a. After completion of service, Pre -receipted Bill for the actual hiring charges shall be raised in duplicate on this office on **monthly basis**. Amount must be written in figures as well as in words in the bill.
- b. Daily duty slip duly verified by the authorized officer shall be attached with the monthly bills as a proof of the service provided.
- c. TDS shall be deducted as per the prevailing Govt. rules.
- d. The attested copy of the challan / receipts of the paid Service Tax as claimed from the department shall be required to be deposited with the Bureau, when asked.
- e. Toll Tax and parking charges shall be reimbursed on actual basis subject to documentary evidence.

8. Penalty Clause:

Misbehavior of driver, Lack of cleanliness of vehicle, and lack of Punctuality of vehicle shall attract penalty. In case of breakdown during transits and the taxi operator failing to provide remedial measures limited to 3 times a month, a penalty equivalent to 2% of the monthly bill shall be deducted.

9. Tender shall be supported by a copy of registration certificate of firm, copy of the Service Tax Number and IT PAN issued to firm, copies of 5 Nos R.C. of commercial vehicles owned by the firm, copies of 5 Nos. valid driving licenses of available drivers and certificates of service provided if any, from the other Government/ Private department.
10. The tender complete in all respects along with **Earnest Money Deposit (EMD) of Rs. 10,000/- (Rupees Ten Thousand)** only in the form of FDR / TD/DD/Bankers' Cheque/BG drawn on any scheduled bank in favor of **AO, PAO, DCPW, New Delhi**, payable at New Delhi and other requisite documents may be dropped in the tender box kept at the office of the DG, NCRB East Block -7, R.K.Puram, New Delhi PIN- 110066. Tender incomplete in any respect and tender without EMD will not be considered.
11. The successful tenderer will have to deposit a performance Security Deposit of **Rs. 25,000/- (Rupees Twenty Five Thousand Only)** in the form of FDR/TD/BG made in the name of AO, PAO, DCPW, New Delhi, which should remain valid for a period of sixty days beyond the date of completion of all contractual obligations including warranty obligations. Security money will be forfeited for breach of any of the terms/ conditions of our tender enquiry and if it is found at any time during the contract period that services provided by the firm are poor/ deficient / unsatisfactory. The decision of the competent authority in this regard shall be final and binding on the firm.
12. The agreement shall ordinarily be valid for a period of 06 months. However it can be terminated by either party by giving 2 (Two) months notice.
13. Once agreement is made nothing extra shall be paid on account of increase in rates of fuel/ taxes (except service tax).
